  - 2021 (15 pg.'s) version from Mark Y Team (Darwin H, Bill M, Mark O).
- Various reasons for the page differences.

# **Comparison**

- Major changes between 2011, 2019 and 2021
  - Elimination of repeated language.
  - Elimination of outdated requirements such as newsletters.
  - Change Board of Directors to Executive Committee to align with the Department
    - VOTE!
  - Switching past Commander Committee seat to an elected seat.
    - VOTE!
  - Directors on the Executive Committee have their terms changed from 5 years to 3 or 2 years.
    - VOTE!
  - Change the Directors election dates to the same as the Post Officers.
  - Change date of election transition from Jun General meeting to 1 Jun.
    - VOTE!

# **Comparison**

- Major changes between 2011, 2019 and 2021
  - Change from two days of early voting to one day with and extra hour added.
    - VOTE!
  - Change any appointments for vacant Officer or Committee positions from Commander appointment/Board approval to Commander appointment/Membership approval.
    - VOTE!
  - Revised all duties of officers.
  - Change requests for Special Meetings from 7 members to 5 members.
    - VOTE!
  - Commander is voting member of Executive Committee.
    - VOTE!
